

- 1. NAME: These rules shall be the rules of the Malankara Catholic Educational Society of the Diocese of Pathanamthitta.
- 2. REGISTERED OFFICE: Catholic Bishop's house, Pathanamthitta, Kerala-689645
- 3 AREA OF OPERATION: The whole District of Pathanamthitta.
- 4. DEFINITION: In these rules unless the context otherwise requires;
  - a. "Society" means the Malankara Catholic Educational Society ( Diocese of Pathanamthitt).
  - b. "General meeting" means a meeting of the general body of the members of the Society.
  - c. "Governing Body" means the governing body constituted in the Manner prescribed by the rules and regulations.
  - d. "President" means the president of the society.
  - e. "Vice president" means vice president of the society.
  - "Secretary" means Secretary of the society.
  - g. "Treasurer" means Treasurer of the society.

PRINCIPAL The society shall uphold the secular and democratic structure of the country, and it mainly focus on imparting Technical and Professional education to the of the community especially the sideling.

- b. The society is aiming to remove poverty from the land providing special education to children of the economically weaker sections of the society

- i. For the further development of the institutions by securing assistance from voluntary organisations, alumina and well wishers without sacrificing the principles of the diocese of Pathanamthitta.
- j. To encourage students by giving them incentives like medals, cash awards and certificates ;appreciating their meritorious success in various curricular; extracurricular and co-curricular fields.
- k. To organise programmes for teachers and students for updating their knowledge in various disciplines and for promoting the cause of nation integration, communal harmony and awareness of social commitment
- 1. To organise foreign exposure to students and faculty members to improve their knowledge in different fields of their studies.
- 6. MEMBERSHIP: The signatories to the Memorandum of Association shall be the first members of the society. Any member of the diocese of Pathanamthitta who is interested in promoting the literary, educational, social and charitable activities of the society be admitted as members of the society, by the Governing Body.
- 7. GOVERNING BODY: The management of the affairs of the Society shall be vested in a "Governing Body". The number of members of the Governing Body shall not be less than seven but not more than eleven. Catholic Bishop of Pathanamthitta shall be the ex-officio President of the Society .The remaining members to the Governing Body shall be elected by the members of the Society at the General Body Meeting.

The meeting of the Governing Body shall be presided over by the President and in the absence of the President by the Vice-President and in his absence the Governing Body shall elect one among them to preside over that meeting.

- 9. Meetings of the Governing Body shall be convened by the Secretary in consultation with the president by giving at least 3 days notice.
- 10. Four members personally present shall be a quorum for a meeting of the Governing Body. No business shall be transacted unless such quorum is present.
- 11. GENERAL MEETING: The General Meeting shall include the members of the Governing Body as well.
- 12. The first General Meeting shall be held within 18 months after the date of registration the holdings of the last preceding general meeting. Such general meeting shall be called the Annual General Meeting.
- 13. Evey General Meeting shall be convened by the Governing Body by giving at least 7 days notice in writing.
- 14. If 30% of the members for the time being on the rolls is present in person, it shall be deemed to be a quorum for the General Body Meeting.
- 15. The president shall preside over all General Body Meetings. In the absence of the President by the Vice-President and in his absence the members shall elect one among them to preside over the day's meeting.

16. The General Body shall maintain or caused to be maintained a book in which the minutes of the proceedings of all the meetings shall be entered. Such minutes shall be signed by chairman of the meeting at which the proceedings were held.

17. The President shall be the guiding figure of the Society and shall have power to enunciate the policy relating to the working of the society, and with the concurrence of the Governing Body, to execute the same in such manner as found fit to foster the development of the objects of the society

18. The Secretary shall be responsible for the proper maintenance of all books, papers gerand other records and for the entire correspondence relating to the business and

The Treasurer shall be responsible for the proper maintenance of all accounts of the society in bank or banks as may be approved by the Governing Body, and the accounts thus opened in the name of the Society shall be operated upon by the President and the Treasurer jointly, who shall also have the power to draw, accept, endorse and negotiate all bills of exchange, cheques, bundies and promissory notes for and on behalf of the society.

- All suits or other actions in any court of law by or against the Society shall be in 20. the name of the secretary for the time being of the society.
- ACCOUNTS AND AUDIT: The Society shall cause to be kept proper books of account in respect of
  - a. All sums of money received and expended.
  - The assets and liabilities.
- The first balance sheet and income and expenditure account shall be laid before the General Body Meeting within 18 months after the registration .Subsequent balance sheet and income and expenditure account of the financial year shall be audited and laid before the General Body Meeting before April 30, every year.
- The first balance sheet and income and expenditure account shall be got audited by an auditor appointed by the general body.
- The balance sheet and income and expenditure account shall be got signed by at least 3 members of the Governing Body.

The Board shall ensure at all times that the funds and income of the Society shall be solely utilized towards the achievement of the objects and aims of the Society and no portion of it shall be utilized for paym at to the members by way of profit, interest, dividend and remuneration, provided however,
